#### 12. Parish Issues/Concerns

Planting Scheme – entrances to the village. Clerk is awaiting visit from the Highways manager to agree the siting of the proposed schemes in the first instance. Clerk to check the overgrown gorse by Waterloo Close and instruct our contractor if required. Daffodils and Primroses are being planted currently.

A proposal was made for the triangle opposite the Watch House by the Environmental Working Party but as this had not been forwarded prior to the meeting, a discussion about the merits/concerns of the proposal took place it but it was agreed that it would be an agenda item for next month to allow all Councillors time to read all the documentation. Any comments/concerns should be made to Cllr Williams before the 31<sup>st</sup> January 2022.

A discussion took place regarding the Cornwall Council Highways Scheme. Options were discussed including applying for an extra camera, so that each village would have one that could be moved around different locations on a more regular basis but it was felt that as one rotation has not happened yet, it was too early.

It was noted that Camper Vans have been parked along Tredenham Road but there are no laws to stop them, Clerk to check with Newquay Town Council who are also encountering problems.

Clerk was requested to obtain the latest position with the encroachment on Upper Castle Road with Cllr German/Highways Manager.
